Understanding the INFPC co-funding application

What is it about?

- ▶ Government initiative to support companies in their training programs;
- ▶ Ultimate objective is to encourage continuing vocational training;
- ▶ Access to the subsidy is obtained by means of a co-funding application;
- ▶ “L’Institut National pour le développement de la Formation Professionnelle continue” (INFPC) is responsible for analysing the applications.

Who is concerned?

- ▶ Private sector **companies** legally established and mainly carrying out their activities in Luxembourg;
- ▶ Training courses must be aimed at **employees**:
 - ▶ affiliated to the Luxembourg social security system (i.e. seconded employees are not eligible);
 - ▶ bound to the company by an employment contract (fixed-term or open-ended).

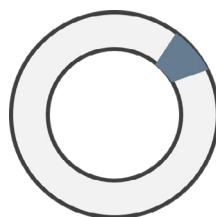

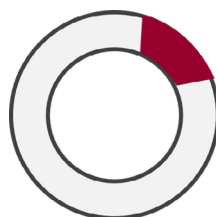
How is the subsidy determined?

The State's financial support amounts to 15% of the cost of the training investment made during the operating year. However, the training investment is capped according to company size.

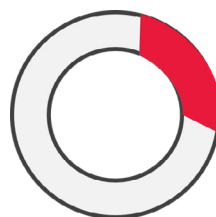
1. Limit set of the training investment according to company size



2% of the total wage bill for companies with more than 249 employees

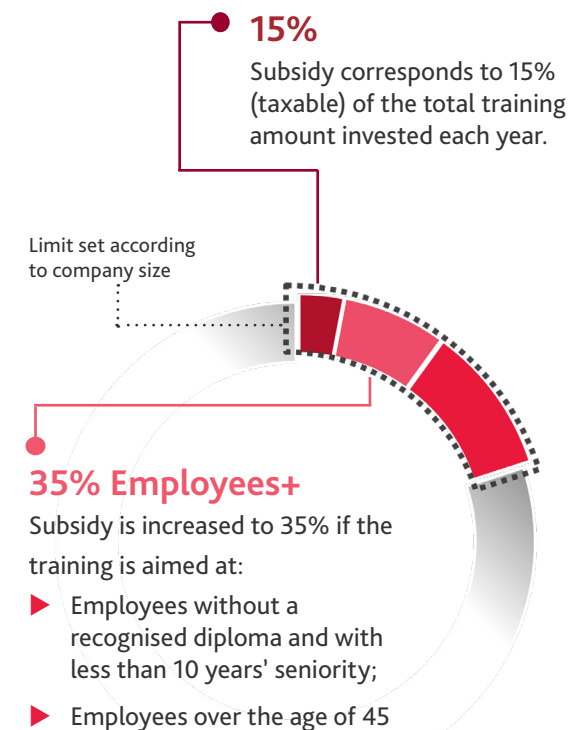


3% of the total wage bill for companies with 10 – 249 employees
