- Internal regulations (if applicable)

Phase 2 : Video working session

- Interview with the Designated Worker / Covid-19 Referent / Health and Safety Delegate
- Realization of the occupational risk assessment related to Covid-19 including a diagnosis of compliance in terms of Occupational Safety and Health (declarative)
- Identification of hazardous situations related to Covid-19

Phase 3 : Occupational risk assessment update

- Co-writing of the occupational risk assessment using our eSST monitoring tool

Phase 4 : Video working session

- Risk scoring
- Plan to improve working conditions
- Prioritization of corrective actions
