

## New deadline for 2019 tax returns: March 31, 2021

In its press release of 21.12.2020, the Ministry of Finance granted an extension for the filing of the 2019 tax returns:

- ▶ The Direct Tax Administration will show exceptional flexibility with regard to the submission of 2019 corporate income tax returns. The administration will exceptionally invite the corporate tax offices not to impose penalties for late filing with regard to 2019 corporate tax returns which are filed on or before March 31, 2021.
- ▶ An extension of the deadline for filing 2019 individual income tax returns has also been granted until March 31, 2021.
- ▶ The deadline for filing a 2020 individual or corporate income tax return is set at the end of June 2021 (instead of March 31, 2021).
